I was recently informed that the bay which I overlook, has been granted several licenses to extend the aquaculture farm 700%.

I feel that the Minster has overlooked the importance of this area while granting this massive expansion.

Why did the Minister grant all of the 45 plus licenses on the one day in December 15 th 2016 using the same stipulations for granting the licenses to all the sites? Surely every site is unique and would need a proper EIS done to access it's affect on flora, fauna and most importantly on the community.

I personally would like to encourage aquaculture development but with proper consultation with the local communities.

My problem here is the massive scale of this development and how it will affect my life, my daughter's life and my property.

This community has tolerated a small oyster farm in this bay for 25 years without complaint.

But it is the huge industrial size scale in an enclosed area of significant beauty and conservation that I disagree with in this particular location of the Gaoth Dobhair/ Braade bay.

I would urge you, the Independant Review of Aquaculture Licensing to ask Minister Creed to view all of these sites separately and access the unique importance these areas.

I want my daughter and I to be safe to walk the strand and not to have to contend with lorries , trestles, workers etc etc.
