Aquaculture is been suffocated to death in Ireland by the lack of understanding and the lack of vision from the Officials that are meant to lead and develop the industry.

The Situation

- Back log of over 600 Aquaculture Licence Applications, not moving
- More Licence applications awaiting decision now than in 2011

Potential

- Up to 2000 jobs from Aquaculture Production and Processing Product
- Additional half a Billion in export revenue
- Copper fasten the Irish Organic in the world Market

Bottle Necks

- No focus on processing licence application
- Too busy trying to penalise genuine operators when the problem are created by the non-activity in Licencing by DAFM
- Public and private Investment of €60 million has been lost in the past five years due to delays in producing licences, badly needed investment that would support Rural communities
- This complete lack of any progress in Licencing has turned away very interested foreign investors in the Irish Aquaculture while Irish Individuals are just giving up

Solutions

- Only one Office should have control over Processing Aquaculture Licences not several Departments and Bodies as is now the case. (listed on last page)
- · Set up an Aquaculture Licencing section in the Office of the new Department of Rural development
- Employ expects to Administer Aquaculture licence Applications in an appropriate time frame with guidance from the Marine Institute and BIM
